Dear Delhi ISAians,

As per the notification released by ISA National HQ regarding ISA State/city branch elections dated 9-7-2026, nature of posts and terms of office bearers and council members have to be mandatorily similar to ISA National posts. Following the directives of ISA National (after discussions with GC ISA Delhi), ISA Delhi branch is seeking nominations from the eligible candidates for the following posts:

1. **President ISA DELHI - One Post**
2. **President Elect ISA Delhi - One Post**
3. **Vice-President ISA DELHI - One Post**
4. **Honorary Secretary ISA DELHI - One Post**
5. **Honorary Treasurer ISA DELHI - One Post**
6. **Editor ISA Delhi - One Post**
7. **GC North Zone - One Post**
8. **GC South Zone - One Post**
9. **GC Central Zone - One Post**
10. **GC West Zone - One Post**
11. **GC East Zone - One Post**

Eligibility Criteria for Candidates Filing Nomination for Above Posts to be Elected Through Online Voting:

At the time of filing nominations:

- A. The tenure of the President, President elect and Vice-President is ONE year. The tenure of Honorary Secretary, Honorary Treasurer, Editor, All Zonal GC Members posts shall be of 3 years.
- B. Honorary Secretary and Honorary Treasurer should file the nomination jointly. Nomination fee for Secretary and Treasurer should be deposited separately.
- C. The candidate should be a **Life-member of the ISA** and her/his membership should be currently **ACTIVE**.

D. **The Candidate should be the member of ISA National FBF scheme.** (mandatory)

E. The candidate must have attended at least two ISA Delhi state annual conferences in last 5 years. Certificates of attendance of the conferences should be enclosed with the nomination form.

OR

Should have attended at least one ISA Delhi State Annual conference in last 5 years along with at least three monthly clinical meetings in last one year, other than own institution. Certificates of attendance of the conferences should be enclosed with the nomination form. The presence in the clinical meetings shall be verified by Honorary Secretary, ISA Delhi.

F. The proposer and the seconder should be **ACTIVE life members** of the Indian Society of Anaesthesiologists, and their names should appear in the Valid Voter list of the ISA.

Timelines for the Election Process

1. Last Date to Receive Nominations: **25 July 2026, 05:00 PM**
2. List of Valid Nominations published: **26 July 2026** (ISA Delhi website)
3. Last Date of Withdrawal of Nomination: **1 August 2026 (upto 05:00 PM)**
4. Final List of Eligible Candidates published: **2 August 2026 (05:00 PM)** (ISA Delhi website)
5. Online voting open: **6 August (08:00 AM) to 10 August 2026 (05:00 PM).**
6. Results declared immediately after voting closes
7. Only **Active ISA Members** are eligible to vote.
